Transcript of the Commissioners Journal as to all the proceedings had in the matter of the application of the Incorporated Village of Flushing for annexation of contiguous territory. Commissioners Office Belmont County St. Clairsville O March 7<sup>th</sup> 1887. The Board of Commissioners met this Day in regular session as provided by law. Present John C. Deuel, H. J. Terry and Morris Cope, Commissioners, and O. A. Darrab Auditor and Clerk of Board. Incorporated Village of Flushing Petition for Extension of Corporation. Our motion it is ordered that the petition be filed and that the case be set for hearing at the Commissioners Office Belmont County St. Clairsville O May 9<sup>th</sup> 1887. And auditor instructed to notify J. W. Hellingersmith Agent of the aforesaid Corporation of time and place of hearing. Yes, Cope, Terry and Deuel. St. Clairsville O May 9<sup>th</sup> 1887. This being the day set for the hearing of the case relation to the extension of the Incorporated Village of Flushing, the same came up for hearing.
