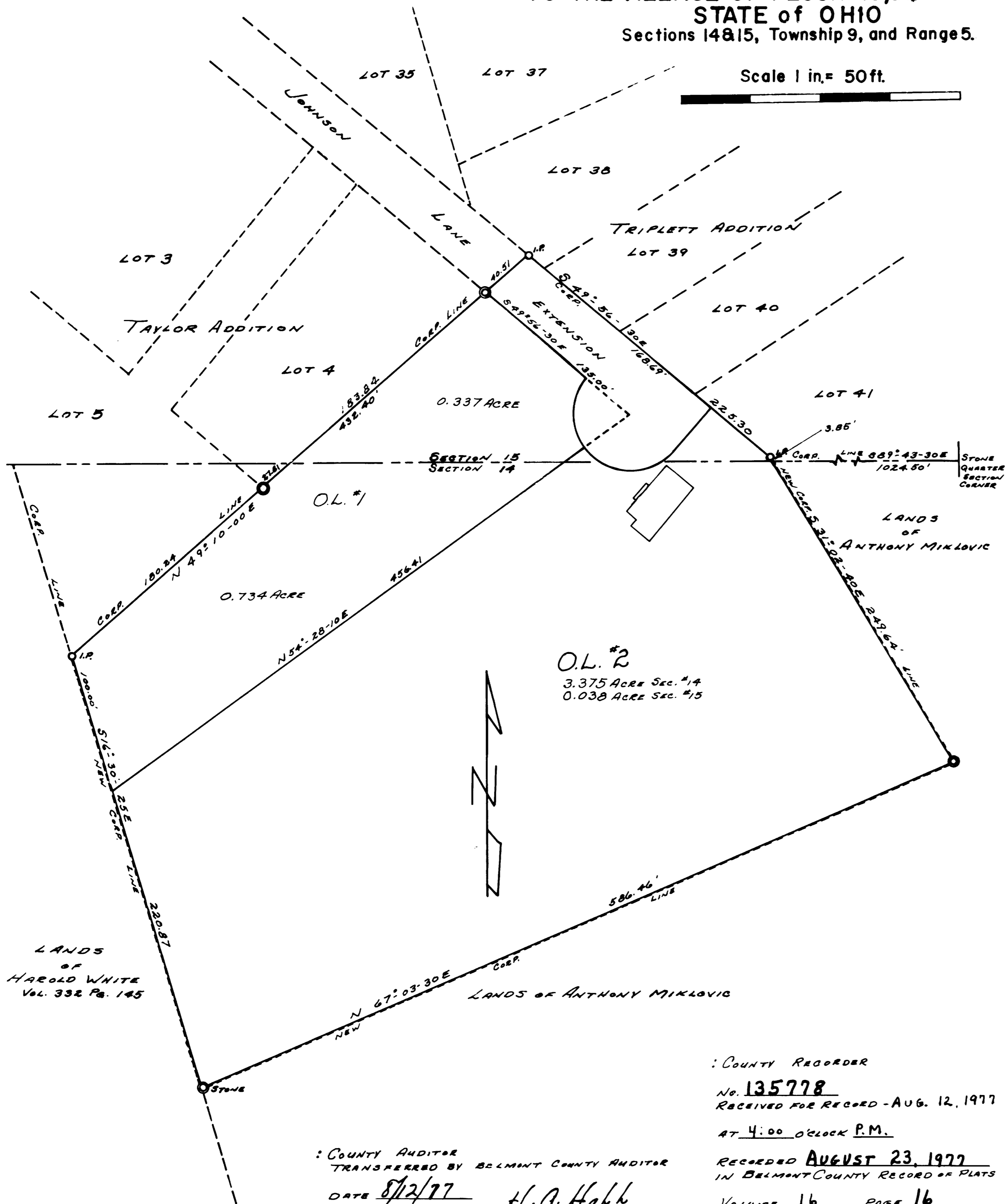


# Annexation of BUGALA ADDITION

**CONSENT & DEDICATION**

WE, THE UNDERSIGNED BEING THE OWNERS OF THE LANDS HEREIN PLATTED DO HEREBY VOLUNTARILY CONSENT TO THE EXECUTION AND RECORDING OF THE SAID PLAT AND DO DEDICATE THE STREET AS SHOWN HEREON TO THE PUBLIC USE FOREVER.

SAID LANDS BEING THE FIRST TRACT OF A DEED RECORDED IN VOLUME 536, PAGE 117 OF THE BELMONT COUNTY RECORD OF DEEDS; AND MORE FULLY DESCRIBED AS FOLLOWS.

SITUATED IN FLUSHING TOWNSHIP, BELMONT COUNTY AND STATE OF OHIO. BEING A PART OF THE NORTHWEST QUARTER OF SECTION 14, AND A PART OF THE SOUTHWEST QUARTER OF SECTION 15, TOWNSHIP 9, RANGE 5. BEGINNING AT A POINT ON THE NORTH LINE OF SECTION 14, WHICH IS N 89° 23' 30" W FOR A DISTANCE OF 102.450 FEET FROM A MARKED STONE ON THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF SECTION 14, THENCE N 1° 02' 30" W FOR A DISTANCE OF 3.85 FEET TO AN IRON PIN; THENCE N 49° 56' 30" W FOR A DISTANCE OF 225.30 FEET THENCE S 49° 56' 30" W FOR A DISTANCE OF 432.40 FEET TO AN IRON PIN AND PASSING ON LINE TWO MONUMENTS MARKING THE CORNERS OF LOT #40, TAYLOR'S ADDITION, THENCE S 16° 30' 25" E FOR A DISTANCE OF 320.87 FEET TO A MARKED STONE, THENCE N 67° 03' 30" E FOR A DISTANCE OF 586.46 FEET TO A MONUMENT, THENCE N 31° 02' 30" W FOR A DISTANCE OF 249.64 FEET TO THE PLACE OF BEGINNING.

CONTAINING 0.586 OF AN ACRE IN SECTION 15 AND 4.113 ACRES IN SECTION 14, DEDICATION FOR ROAD PURPOSES 0.215 OF AN ACRE MORE OR LESS.
