to an iron wood bush, thence south 42° east 225 to a stake, thence south 89° west 581 feet to a stake, thence south 40° east 760 feet to a post, thence south 89° west 400 feet to a stake, thence south 80° east 425 feet to a stone, thence north 89° west 10 feet to the south east corner of John Murphy's lot, thence south 42° east 105 feet, thence south 81° 55' west 500 feet to a telephone pole west of the fence, thence south 87° west 100.75 feet to a stake, thence north 89° west 294.5 feet to an iron pin on the south west corner of Barnum's Addition, thence north 42° west 300 feet to a stone, thence south 89° west 933.5 feet to a stone, thence north 1° west 10 feet to a stake on the north side of the Baltimore and Ohio Railroad, thence north 66° east 118.75 feet to a stake at the south west corner of Hunt's First Addition, thence north 1° west 2579 feet to a stake on the north side of the county road leading from Barnum's Addition to Bethesda, thence north 82° east 100 feet to a stake, thence north 345 feet to a stake, thence north 84° west 702 feet to John Nelson's line, thence south 24° west 502 feet to a stone at the north west corner of the lands of John Nelson, thence north 42° west 300 feet to a stake, thence north 89° west 100.25 feet to a stake on the quarter section line, thence south 42° east 300 feet to the place of beginning, containing 300.00 acres.
